

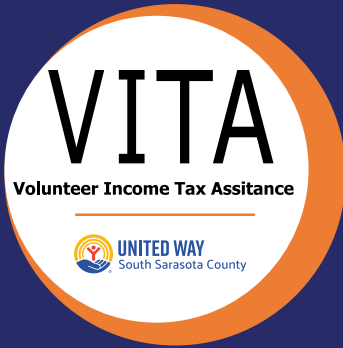
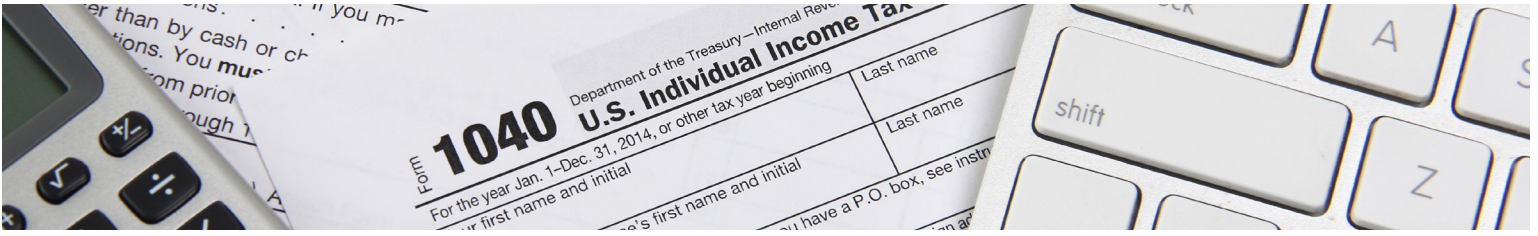

If Married and Filing Jointly, **BOTH** Spouses must be present.

- A Copy of Last Year's Federal Tax Return
- Taxpayer's Valid Gov't Issued Photo ID
- All Forms, W-2, 1095, 1098, 1099 (PRINTED-No Images)
- Information for Other Income
- Identification number for Child Care Provider
- Information for Deductions/Credits
- Proof of Account for Direct Deposit or Refund (e.g. voided check)
- Social Security Cards and/or ITIN Notices/Cards for You, Your Spouse and Dependents
- Bring COMPLETED Intake Form 13614-C to Appointment
